Other topics of discussion include the following: Issues with using Tax Commission funding for Economic Development, Tax Commission needs to be considered carefully when being put into Constitution Housing continues to grow, Housing Committee is a SCN-initiative and not required by federal regulation As processes and enterprises grow it may be important to transition to say a Housing Authority or Election Board Codifying laws is taking place and it is necessary Politics runs business within our community and that hurts our businesses or lack thereof Distinction between General Council and Business Committee oversight should be considered when drafting new articles There are few Constitutional safeguards currently in place, a part of this work is looking at what is currently happening and recording that in amended articles, as well as strengthening processes already in place eg. Grievances, General Council Resolutions, etc. Right to open records needs to be clarified in Duties of Officers, it has been weaponized against tribal members in the past Clarification of location of safe places under tribal jurisdiction in event of paper ballot storage | |
