| | Grievance Committee member states that an often talked about issue is making quorum for Removal Hearings Historical quorums have been 225 and 30, currently quorum requires 150 General Council members for a Special Meeting of the General Council Grievance Committee members are asked what an appropriate quorum for a Removal Hearing is and generally agree on one of two answers, either "at least 100" or the present 150 members Currently it is a struggle to get 150 General Council members together Grievance Committee hopes to have their revised Grievance Ordinance in time for the 2026 Annual Meeting of the General Council Grievance Committee is asked if having a specific day designated for Grievances (e.g. Saturday) would help with General Council attendance at meetings Grievance Committee member agrees that Saturday General Council meetings would facilitate attendance Current Grievance Ordinance provides for calendar days in calculating time frames so they would have to specify that the following Saturday is the specific day to hold a Removal Hearing during a Special Meeting of the General | |

| | Council Grievance Committee members agree that the current Grievance Committee quorum is appropriate for the Evidentiary Hearing and that a quorum for a Saturday Special Meeting of the General Council is appropriate for a Removal Hearing Grievance Committee is asked what they think about extending Grievances over all elected officials, not just the Business Committee as it currently stands Grievance Committee members agree that their Committee and Grievance process should oversee all elected officials of Standing Committees, with all removals under the purview of the General Council Non-elected committeeperson removals would fall under the purview of their respective creator e.g. the Enrollment Committee can ask the General Council to remove a member who otherwise has lifetime membership in Enrollment Committee Constitution Committee Constitution Committee member asks how due process can be ensured for Grievance Committee members who may have a Grievance filed against them If the Grievance is handled entirely on the floor at a meeting of the General Council then there is a possibility that due process would not be fulfilled and open up the tribe to civil rights lawsuits Due process for an accused Committeeperson does include having the opportunity to fight the Grievance Possible solution is for the accused Grievance Committee member to recuse themselves from any Grievance proceeding filed against them; this is a situation where an already elected alternate would be relevant Having 4 members on Grievance Committee experiences in recent Grievance Committee | |

| TIME | Having an already elected alternate for the Grievance Committee would be relevant for recusals due to immediate family or household members, or resignations due to health issues Constitution Committee member proposes a 3 member Grievance Committee with 2 alternates that attend all meetings provided there are no conflicts of interest; Grievance Committee members agree this could work An open records policy is important to the Grievance Committee and their work Not receiving information from a Secretary-Treasurer in a timely manner can hinder an investigation Grievance Committee has not been denied records recently, though there have been a few times when the Secretary-Treasurer communicated that they did not have the requested information Previous records request denials included concerns over the legality of viewing the stipend paystubs of elected officials Several Constitution Committee members present state they believe elected official stipends to be public record Grievance Committee is asked if it would be beneficial to have an explicit open records guarantee and/or relating to their investigations, Grievance Committee members agree Grievance Committee members agree Grievance Committee members agree Grievance Committee members agree later on that 5 business days is an appropriate timeframe for a Secretary-Treasurer to | OWNER |

| | mail it out to the accused The accused has 21 days to respond and the Grievance Committee takes the time to investigate the Grievance Once the response is received then there must be a 20 day wait before calling an Evidentiary Hearing There is no deadline for the calling of an Evidentiary Hearing, this can result in a Grievance Committee not calling a Evidentiary Hearing even when obligated to Grievance Committee is rewriting the Grievance Ordinance to require an Evidentiary Hearing be called within a certain timeframe of receiving a response to close this loophole Question asked of the Grievance Committee — do you as a Committee feel empowered to call a meeting of the General Council? Grievance Committee member says "It's not clear" and members cite By-Laws Article I Section 1 "It shall be the duty of the chief to preside at all meetings" This gives the discretion to any Chief to delay proceedings and not call to order a Removal Hearing and/or creates a conflict of interest if the accused individual is the Chief | |

| TIME | By-Laws Article I Duties of Chief section carefully so it does not prohibit the Grievance Committee from presiding over a Removal Hearing By-Laws Article III Section 2 "Special meetings of the council may be called by the Chief, and shall be called by him upon [written requests of majority of BC or 150 members of the Nation]" is interpreted in different ways by Constitution Committee members when discussing possible limitations it creates on a Grievance Committee Removal Hearing being scheduled Constitution Article X "The Grievance Committee [] upon proper showing shall call a special meeting of the Seneca-Cayuga Council to act upon such complaints." Multiple references across the Constitution are often interpreted in contrast to each other There are multiple loopholes that also create conflicts of interest that have before and may continue to limit General Council powers and due process The two concepts of the General Council of the Nation (all members 18+) and the assembled General Council at an Annual or Special Meeting does create an issue depending on the interpretations made in practice, and can lead to disenfranchisement of the General Council Structure of Government Article drafting can include differentiating between the two so the rights of the General Council are understood better Call to Grievance Committee members for questions for the Constitution Committee, if any Grievance Committee member brings up lack of conduct standards for General Council members during Removal Hearings in the Constitution | OWNER |

| Grievance Committee member notes that it would be important to make sure that Grievance Committee covers all Committees including the two General Council members on Tax Commission if they are elected Other duties outlined could include to determine and investigate showings or acts of misconduct Grievance Committee is asked if the current grounds for Grievances listed in the Grievance Ordinance is appropriate? "For the most part" Grievance Committee member says it should be clear that they only find if there is a "proper showing of misconduct" and there is no guilty or not guilty involved Question for the Grievance Committee – Should poor hiring choices at the enterprise management level be grounds for Grievances on the Business Committee? Grievance Committee member states that if there is an issue with a candidate for casino management then it could be addressed by a Gaming Commission who holds the authority to approve or disprove casino management licenses outside of the Business Committee's choice to hire a candidate, gaming licenses are privileges, not rights Current Gaming Commissioner is not a tribal member Background checks by Gaming Commission will catch any convictions that disqualify employee candidates from licensure Poor hiring choices by the Business Committee is already generally addressed by the Grievance procedure | |

| | investigation into claims regardless of perceived merit is a part of the Grievance Committee job The person filing a Grievance is required to provide their evidence at the time of filing Question for the Grievance Committee – How important do you think it is for the General Council to hear from each elected Committee about their activity during the year at the Annual Meeting? Grievance Committee member states that they don't see an issue with providing a general synopsis of the year – e.g. we had 3 Grievances this year – and to not include details Constitution Committee member asks rhetorical question "What right to privacy do tribal members have for finished grievances? What right do tribal members have to know if a Grievance is filed and on whom?" When Evidentiary Hearings for Grievances are posted they do provide the names of involved | |
| | elected officials Constitution Committee and Grievance Committee review if Grievance Committee is subject to Robert's Rules By-Laws Article III Section 6 states "All meetings of the General Council and Business Committee shall be conducted pursuant to the most current version of Robert's Rules of Order []" There appear to be no written provisions explicitly binding the Grievance Committee to the use of Robert's Rules of Order Grievance Committee member requests the taking out of Robert's Rules of Order from our tribal governing documents Grievance Committee is asked if there's anything they would like to see in their own personal opinions with the Constitution Making sure the agendas and their changes are posted in a timely matter for Annual Meetings, even up to a month before (possibly in the duties section) Folks generally agree that two digital postings | |

| | An audio recording of the Business Committee monthly meeting on October 07, 2025 was provided to a Constitution Committee member who listened to it and reports that the Secretary-Treasurer mentioned that the interpretation of her duties is "something that needs to come up to the Constitution Committee." The Secretary-Treasurer has not responded to 3 different Constitution Committee member requests for non-financial documents, nor has the Secretary-Treasurer communicated needing help with the interpretation of aforementioned duties Constitution Committee member states that this situation seems to rise to negligence of duty Business Committee member present states that they cannot fully address this matter in their official capacity There is no Freedom of Information Act or similar process within the Nation to compel information including financials Business Committee member present states that the scanning and organizing of Resolutions done by prior Secretary-Treasurer Kim Guyett has been lost by current administration Constitution Committee member reminds Business Committee member reminds Business Committee member that they still have access to majority of Resolutions from 2014-2023 and that | |
