I pledge to protect our Nation from any action or influence that would undermine, defraud, or diminish its jurisdiction or inherent rights. ○ I further affirm that I will serve with honesty, integrity, and respect for the laws and values of our people. I will not mislead by false statement, nor act in any manner that compromises the trust placed in me. I will conduct my duties with dignity, decorum, and the highest level of fiduciary responsibility, guided always by truth, justice, and a commitment to the collective well-being and advancement of the Seneca-Cayuga Nation—its culture, languages, and citizens. ○ With this oath, I commit myself to faithful,
