Position Title: Flint Fire Mercantile Cashier

Department: Flint Fire Retail Operations

Immediate Supervisor: Store Manager or Assistant Manager

Position Supervised: None

General Statement of Responsibility: The Mercantile Cashier is responsible for providing excellent customer service while accurately processing sales transactions. This position also supports daily store operations, including stocking, cleaning, and maintaining a welcoming environment for all customers.

Specific Areas of Responsibility:

- **Customer Service:** Greets customers, assists with product location, answers questions, and provides friendly and efficient checkout experience.
- **Cashiering:** Operates the cash register, processes cash, credit, and other payment methods accurately.
- **Fuel Services:** Assists customers with fuel pumps if needed (though self-service is common in Oklahoma), and ensures pumps are clean and functional.
- **General Store Operations:**
 - Stocks shelves, rotate products, and checks for damaged & expired items.
 - Maintains cleanliness of aisles, displays, and entryways.
 - Receives and assists with deliveries.
 - Assists with inventory counts.
- **Cleaning & Maintenance:** Performs general cleaning duties throughout the store and restrooms, including sweeping, mopping, trash removal, glass cleaning and cleaning gas pump areas.
- **Security:** Monitors for shoplifting or suspicious activity and reports issues to management.
- Capable staff can begin to operate as shift supervisors and begin to earn a higher range of salaries.
- Other duties as assigned.

Qualifications and Requirements:

- High school diploma or GED preferred.
- Prior retail or customer service experience is a plus but not required.
- Basic math skills and ability to handle cash accurately.
- Excellent communication and customer service skills.
- Reliable, honest, and able to work in a fast-paced environment.
- Obtain and maintain a liquor license.
- Willingness to work flexible shifts, including nights, weekends, and holidays.
- Must be able to pass a background check and drug test.

PHYSICAL REQUIREMENTS:

- Retail store setting may involve exposure to outdoor conditions at fuel pumps.
- Use of POS system, cleaning chemicals, and handling of food and beverages (if applicable).
- Ability to stand for extended periods (entire shift).
- Must be able to lift up to 25–40 lbs.
- Frequent bending, reaching, and lifting during restocking and cleaning tasks.
